APA Applauds Passage of Opioid Legislation; Calls on Senate to Pass Legislation On October 3rd, the Senate passed H.R. 6, the SUPPORT for Patients and Communities Act, which authorizes a broad range of opioid treatment and prevention programs, including many for which the APA has advocated. The bill does not include The Overdose Prevention and Patient Safety (OPPS) Act, H.R. 6082, which recently passed the House of Representatives by a bipartisan vote of 357-57.

"Opioid use disorder has taken a heavy toll on the health and well-being of Americans," said APA President Altha Stewart, M.D. "The APA is grateful to see bipartisan support for increased access to treatment for substance use disorders, including expanded access to residential treatment and medication assisted treatment. We are also pleased to see provisions in H.R. 6 to deter opioid abuse. Together, these efforts take many important steps toward combatting the opioid crisis across the country. However, we are disappointed that the final bill did not include critical reforms to align 42 CFR Part 2 with HIPAA, which could improve care coordination and patient safety for the treatment of substance use disorders while preserving patient privacy. This much-needed legislation passed the House earlier this year with overwhelming bipartisan support. We urge the Senate to hold a separate vote on the OPPS Act to ensure that these enhance patient safety, care coordination, and consumer protections become law."

PROGRAMCMS Admits Errors in MIPS Payment Calculations

In addition to those whose scores were directly impacted, some clinicians will see small changes in their payment adjustment after budgeting.

WHAT HAPPENED: CMS has announced the agency made mistakes related an undisclosed number of providers when processing their quality scores in the first year of participation for the merit-based incentive payment system, or MIPS.

THE EXPECTED IMPACT: The errors made means that those providers were paid incorrectly under the MIPS program. Fixing the mistakes meant changes to the 2017 MIPS final score and associated 2019 MIPS payment adjustment for the clinicians impacted by the issues. Also, some

clinicians will see small changes in their payment adjustment as a result of the reapplication of budget neutrality.

MGH Study Finds Major Increase in US Healthcare Data Breaches

Since 2010, the total number of healthcare data breaches has increased steadily every year – except in 2015 – from 199 in 2010 to 344 in 2017, according to an <u>analysis</u> of US health care data conducted by two Massachusetts General Hospital (MGH) physicians.

While 70 percent of all breaches took place at health care providers, breaches involving health plans accounted for 63 percent of all breached records. In fact, health plans accounted for the greatest number of patients records breached over the study period.

Their analysis covered 2,149 reported breaches involving 176.4 million patient records, with



nging from 500 to almost 79 million patient records. Their report examined data breaches during a period when EHRs were widely adopted.

HHS Awards Over \$1 Billion to Combat the Opioid Crisis

The U.S. Department of Health and Human Services awarded over \$1 billion in opioid-specific grants to help combat the crisis ravaging our country. The awards supports <u>HHS's Five-Point</u> <u>Opioid Strategy</u>, which was launched last year and enhanced this week. New data unveiled recently by HHS suggests that efforts are now yielding progress at the national level.

"Addressing the opioid crisis with all the resources possible and the best science we have is a top priority for President Trump and for everyone at HHS," said Secretary Alex Azar. "The more than \$1 billion in additional funding that we provided this week will build on progress we have seen in tackling this epidemic through empowering communities and families on the frontlines."

SAMHSA awarded more than \$930 million in <u>State Opioid Response grants</u> to support a comprehensive response to the opioid epidemic and expand access to treatment and recovery support services.

The grant aims to address the opioid crisis by increasing access to medication-assisted treatment using the three Food and Drug Administration (FDA) approved medications for the treatment of opioid use disorder, reducing unmet treatment need, and reducing opioid overdose-related deaths through the provision of prevention, treatment, and recovery activities for opioid use disorder.

FDA Approves Higher Dosage of Buprenorphine/Naloxone

The Food and Drug Administration (FDA) on Friday announced its approval of Cassipa, a sublingual buprenorphine/naloxone film, for the maintenance treatment of opioid use disorder (OUD). Cassipa, manufactured by Teva Pharmaceuticals, provides 16 milligrams of buprenorphine and 4 milligrams of naloxone per film, which is a higher dose than currently available with brand-name or generic buprenorphine/naloxone sublingual formulations.
