DEAR CREDIBLE,

**New beta versions of the Credible Care for iOS, Android, and Windows will be available by this Friday, February 2!**

Partners participating in the beta test will soon receive an email from TestFlight (iOS) or Crashlytics (Android) with links for accessing the new versions.

Partners participating in the Windows app beta test will receive an email from Credible with a .zip file containing the beta build.

### What's New in Credible Care 1.11 for iOS

- **Family:** Users can now add, edit, and delete family members. Family can be added by manual entry or be linked to an existing client.
- **Credible Plan:** Users can now view Credible Plans, the new version of treatment plans, on mobile.
- **iPhone X:** Optimizations for the new form factor and support for unlocking Credible Care with Face ID.

Additional enhancements and minor corrections are also included in this upgrade.

### What's New in Credible Care 1.5 for Android

- **Family:** Users can now add, edit, and delete family members. Family can be added by manual entry or be linked to an existing client.
- **Credible Plan:** Users can now view Credible Plans, the new version of treatment plans, on mobile.

Additional interface enhancements and minor corrections are also included in this upgrade.

### What's New in Credible Care 1.0 for Windows

This is the first iteration of Credible Care for Windows. Care for Windows is a limited subset of the features currently in the iOS and Android apps, but will be brought to parity in upcoming releases.

- **Scheduling:** Users can view their schedule and add new visits or admin time.
- **Forms:** Users can complete forms for visits, group visits, form groups, and orphan visits. Answers, notes, signatures, billing information, and Tx Plus documentation can all be completed.
- **Client Records:** Users can view a client's information, allergies, contacts, diagnosis, family, Tx Plus, and photo.
- **Cross-Platform:** Forms can be started on either platform and finished on the other. For example, a visit started on the web can be completed on Care, or vice-versa.
- **Disconnected Mode:** While disconnected, form answers and information are saved locally until the next connected login.
