## June Enhancements & Task Release

DEAR CREDIBLE,

Last night, Credible's Tech Team successfully deployed our June release, as described in [our previous communication](#). This release included 28 PPIs, 101 PBIs, 5 major features, 17 enhancements, and 29 task resolutions, as well as many "behind the scenes" improvements to speed and efficiency.

In addition to the previously listed items, two new enhancements were included in this release, as shown below.

### Client Portal Visit Status

Credible now includes the functionality to approve a client portal visit with or without mapping to Credible Core. This functionality allows Partners to determine whether the information entered through a Client Portal Form should be mapped to Credible Core when approved a visit. ## Extended Employee Schedule Subscription

With the setting **Partner Config: Use Outlook Export** checked, your Outlook calendar can be automatically updated with items from your Credible Schedule by creating a subscription. This listing is updated every 30 minutes, and retrieves 42 days of data. Previously it only retrieved the next 8 days. Details can be found in Credible Help at [Automated Export of Schedule to Outlook via Subscription](#).

During deployment, Credible's Quality Assurance team determined that the function below did not meet the exact criteria for ease of use and standards compliance our Partners expect. Therefore, Executive Management made the decision to withhold deployment of the following item until additional testing can be performed.

- **Tall Man Lettering in Medication History:** This function has been withdrawn pending additional QA research.
