

Subject:	Credible Update: WaMS Live - Next Steps



DEAR CREDIBLE,

Credible was pleased to be able to make WaMS available to Virginia Partners on August 27, 2018, and subsequently have Partners be able to successfully submit to the state. Over the past month, Credible has been working with State of Virginia and Virginia Partners to make additional adjustments and enhancements to WaMS functionality.

Below please find a summary of additional updates released since WaMS GoLive:

- September 4th
 - Automate the Provider List import
 - Update VIDES scripts to ensure file batching
- September 7th
 - Automate the WaMS Application, which automatically runs the Exports, creates a batch, and submits the batched files to WaMS

• September 10th and September 25th

- o Corrected a VIDES batching issue
- Corrected a VIDES and ISP Reports data truncation issue

• October 5th

- Enabled all relevant ISP Services to be included in the batch and WaMS transmission
- October 9th
 - Corrected the ISP Agreement Signature block

Additional updates are forthcoming and will address the following:

- ISP Allergies section
- ISP Work Desire question
- Update to Education Level lookup
 - There is a crosswalk between the CCS Consumer Report Education Level and the WaMS ISP Report Highest Education Level; however it is not documented by the State. Credible is waiting for confirmation from the state regarding the correct crosswalk; once the accurate information has been received, Credible will distribute the updated lookup table to Partners in order to update the configuration.
- Increase Credible Plan Support Provider Name field width
- Update Credible Plan Support Provider Name to be a multi-select field
- Enhancement to provide Error Validation Reporting for ease of use in identifying data errors prior to submission. This has a targeted completion date of Q1 2019.

Credible is dedicated to ensuring WaMS is successfully submitted for all Virginia Partners and is actively monitoring WaMS during this transition period. If your Agency is in need of additional support, please submit a task ticket and a Data Analyst will be happy to assist you.
