New States

Credible welcomes the states of New York, New Jersey, West Virginia, and Georgia to the Credible Family! Credible's Billing and Financial Services Department looks forward to assisting you with your billing needs.

CCBHC Update

Credible is beginning the next phase of CCBHC support – Billing Configuration. CCBHC Demonstration Grants have been awarded to the following states: Minnesota, Missouri, New York, New Jersey, Nevada, Oregon, Oklahoma, and Pennsylvania. In Mid-February, Credible will be hosting state-specific trainings on how to reconfigure your Billing Matrix and Billing Config to support CCBHC billing for Missouri and Oregon. Additional support from the Billing Department is available upon request through the submission of a Task Ticket. State-specific trainings for Minnesota and Pennsylvania will be made available once both states release EDI configuration and billing requirements.

State-Specific Notes:

- **Minnesota**: Billing Guidelines have not yet been released by the state. State meetings began on 2/2/17, at which a Credible representative was present.
- **Missouri**: Payer testing will begin March 1, 2017. Credible state-specific trainings are scheduled for February 14, from 12pm-2pm EST. <u>Click here to register!</u>
- **Oklahoma**: No Credible Partners have reported that they will be demonstrating.
- **Oregon**: GoLive for implementation is on April 1, 2017. Credible state-specific trainings are scheduled for February 15, from 12pm-2pm EST. <u>Click here to register!</u>
- **Pennsylvania**: Billing Guidelines have not yet been finalized by the Commonwealth. State meetings are occurring biweekly beginning 2/21/17. A Credible representative will be present for these meetings.

Payer Announcements

- Arizona
 - AHCCCS: CMS approved Arizona's request to begin Targeted Investments
 Programs (\$300M over 5 years) to AZ providers who assist the State in promoting
 Integrated Care. Please see <u>this link</u> for more information.

Arkansas

- Medicaid: Arkansas Works implementation begins. An extension of the Waiver 1115, Arkansas Works began on January 1, 2017. The largest impact for consumers is a \$13 a month premium for enrollees whose households are 100% over the Federal Poverty Level and are also in QHP/ESI. - Medicaid: Upgrade to a new MMIS is still on target for mid-2017. Please see <u>this link</u> for ongoing updates.
- Ohio
 - Medicaid: The Behavioral Health Redesign efforts are on target for implementation on July 1, 2017. Credible is in contact with Ohio Medicaid, has attended the Redesign meetings, and will continue to strive to be up to date in proactively supporting Ohio Partners with the implementation. Credible will be offering Billing Configuration webinar trainings in April 2017. - Texas
 - Medicaid: HHSC has received approval for the 1115 Waiver to expand Medicaid Managed care.
