Certified Version Available August 15, 2014

Credible Behavioral Health 9.1 attained 2014 Edition Complete Ambulatory EHR Certification from the ICSA Labs ONC Health IT Certification Program. This designation means that the software can support Eligible Providers with Stage 1 and Stage 2 Meaningful Use measures required to qualify for funding under the American Recovery and Reinvestment Act. This Complete EHR is 2014 Edition compliant and has been certified by an ONC-ACB in accordance with the application certification criteria adopted by the Secretary of Health and Human Services. This certification does not represent an endorsement by the U.S. Department of Health and Human Services.¹

Credible Behavioral Health 9.1 includes support for "Surescripts 10.6" and was certified on July 17, 2014 by Surescripts for prescription routing messaging: NewRx, RxRenewal, STATUS, and ERROR.

This release consists of features in the certified version that were not released in May 2014. For example, in Tx Plus, your Administrator can now configure active/inactive statuses for Tx Plus elements and have staff select them from a dropdown. And for Credible eRx, there is a new Security Matrix right for the "Supervising Provider on Script" requirement and new fields on the "finalize prescription" screen.

On the secure messaging front, your staff can use the Messaging Hub to initiate an electronic conversation with a client's authorized users — the first message is received in the Credible Client Portal. In Credible eLabs, there is a new Attachment Type dropdown for lab results so staff can specify if the attachment is an image and/or narrative or "other".

Another release highlight is a new Viewable By dropdown in the Clinical Support Admin screen — with it your Agency can restrict the employees that can view a clinical support once it has triggered.

Dropdown Format for Active/Inactive Flag for Tx Plus Elements

If your Agency's domain is configured to allow deactivation of individual elements in a Tx Plus plan, your staff will notice that the Inactive checkbox has been replaced with an Element Status dropdown.



Your Administrator can rename the two default options and add additional statuses via *Manage Tx Plus Element Status Type* in Partner Config.

When an inactive status is selected, a reason field in the Tx Plus element displays (it replaces the Inactivation Reason popup).



When a user reactivates an inactive element by selecting an active status, a new reactivate confirmation prompt displays.

New Right for "Supervising Provider on Script" Requirement

If a Credible eRx Prescriber ("provider") requires a supervising provider on prescriptions when they are printed/sent to the pharmacy, your Administrator needs to select the new Security Matrix right RequireSupervisingProvidereRx for his/her profile. When a provider has the right and he/she is selected from the Provider dropdown on the Create Prescription screen (or the provider is creating the script himself/herself), the Supervising Provider dropdown displays and selecting one becomes a requirement.

New Fields Added to Credible eRx "Finalize Prescription" Screen

In accordance with Surescripts requirements and to help ensure the accuracy of a prescription before you submit it, the following fields have been added to the "finalize prescription" screen: Client gender/DOB, Provider phone/address, date/time script was written, and Pharmacy phone/address. In addition, the screen now has a reminder that Additional Comments entered go to the Pharmacy – they are not viewable by the client.

Initiating Electronic Conversation with Client's Authorized Users

To improve Agency-client communication, New Message functionality has been added to the Messaging Hub. If an assigned client has one or more client users, staff can use the Messaging Hub to send the first message in a conversation to the Credible Client Portal. If the client has a client user with the MessagingCU right, he/she will be able to view and reply to the message.

Specifying Attachment Type for Lab Results Attachment

The Lab Results function in eLabs has been enhanced with the addition of an Attachment Type dropdown. When adding an attachment to a lab result, staff will have to identify what type it is by selecting the corresponding option from the Attachment Type dropdown.

Once a file is attached, it will have an icon that corresponds to its attachment type. Hovering over the icon displays the attachment type and the number of attachments.
